Registration is full at 75 artists and is open to members who have joined as of SEPT 2017 and attended a meeting*. New members must be juried. Registration fee is \$90.00 and raises to \$110 after Nov 19. Fees are non-refundable after Nov 27th unless another artist can fill that spot. Fees will be returned to those who are not accepted.

Artists who will only display ornaments or books, fee is \$45, but display space will be limited.
